Set-Up and Times:

The Expo will run from 11:00am – 7:00pm on Friday, October 20, 2017, and from 8:00am – 12:00pm on Saturday, October 21, 2017. Vendors **MUST** be present the **ENTIRE** time. Vendors will be able to set-up their booth beginning at 8:30 am on Friday, October 20th. Old Glory Distilling Company Event Center is **NOT** responsible for any lost or stolen items from vendor booths. Please secure your belongings.

Exhibitor Fees:

Each exhibitor booth (10x10) is \$200. Non-profit vendors are \$100. The booth space will include the following: 10'x10' space, 6 foot table, two chairs, and booth sign. Electricity can be provided but **MUST** be requested **AT LEAST ONE WEEK** prior to expo. Exhibitors also have the opportunity to host product demonstrations/sampling, sell products and interact with race participants.

VENDOR AGREEMENT:

1. No refunds will be made to exhibitors who fail to set-up for the expo.
2. All booth spaces must be paid in full prior to set-up.
3. The Go Commando Half Marathon and 5K reserves the right to reject, restrict, or eject any vendor exhibiting inappropriate merchandise or behavior. (No refunds will be given if ejected.)
4. Exhibitors must remain for the entire expo, Friday, October 20, 2017 from 11:00am – 7:00pm.
5. Exhibitor will allow event staff to take photographs of their booth for promotional purposes only.
6. All exhibitors must adhere to local fire department rules and regulations.
7. Local city and county agencies, Old Glory Distilling Company and/or employees of said organizations will not be held liable to exhibitor's agents, invitees, licensees and/or visitors or to any other person for personal injury or property damage on or about the premises caused by the negligence or misconduct of exhibitor, its agents, servants, or employees, or any other person entering the premises under express or implied invitation of the exhibitor.

8. Exhibitor agrees to indemnify and hold harmless the Clarksville Rotary Club, local city and county agencies, the Old Glory Distilling Company and/or employees of said organizations from any loss, attorney's fees, expenses, or claims arising out of any such damage or injury.

All power cords that protrude outside of the vendor's 10x10 space must be covered with a floor mat provided by the vendor.

2. Exhibitor agrees not to deface property and agrees to accept liability for any damage to property of others. Any damage shall be remedied at exhibitor's expense and to the satisfaction of the property owner.
3. In the event of war, fire, terrorist attack, public catastrophe, act of God, civil unrest or other uncontrollable cause, the Expo and any part thereof is prevented from being held, or cancelled, the Go Commando Half Marathon & 5K shall have the discretion to issue a refund.
